# LWEA contract will be reopened if levy fails

Many LWEA members may be unaware that our contract immediately becomes fully open if there's a levy failure. The levy provides about 20% of the district's budget, so the loss of that funding would significantly impact the district's ability to pay for many items we've negotiated in our contract.

Here are some of the things in our contract that will be up for renegotiation if the levy fails:

- Attract and Retain bonus (range of \$500 to \$9,000)
- Responsibility Contract (range of \$8,782 to \$15,917)
- Professional Fund (\$2,000)
- Tech Stipend (\$2,000)
- LEAP Days (range of \$1,623 to \$2,942)
- Elementary counselors
- Librarians
- IA time for librarians
- Elementary music and PE teachers
- Class size limits and remedies
- Caseload limits and remedies
- Special education caseload management time
- OT, PT, SLP, psychologist national certification bonus (\$3,000)
- Paid planning time
- New Teacher Support Program
- Instructional assistants for elementary bus and recess supervision
- Department chair release time
- Kindergarten WAKids compensation
- Secondary multiple prep remedy (\$1,000)
- Elementary Safety Net teachers
- Secondary Safety Net classes
- High school graduation support money
- Subs for DIBELS testing
- Extended days for counselors, librarians, psychologists, and OT/PT/SLP/VOM
- Transfer pay (5 days)
- Use of sick leave for paid child care leave
- Extracurricular stipends
- Personal (annual) leave

## **Retirement in your future?**

If you see retirement in your near future, there are a few things you might want to plan to do before you reach that last day. Here are a couple of resources that will make this change easier and less stressful:

- Make an appointment with the Department of Retirement Systems (DRS) to go over your service credit and years of experience. It is a good idea to check the accuracy of your records now rather than deal with problems later. You can make an appointment by calling the DRS at 800-547-6657, by e-mail at recep@drs.wa.gov, or on the website.
- Attend one of the District's informational meetings. Payroll staff will be going over topics such as sick leave cash out, VEBA, COBRA, medical and optional benefits, etc. Meetings are being held at 4:00 PM at the Resource Center on these days:

## Learn About National Board for Professional **Teaching Certification**

Have you been considering pathways towards professional certification? Then we invite you to attend one of the information sessions located at the LWSD Resource Center:

- March 29 Hughes, 4:30-5:30 PM
- April 19 Curriculum Library, 4:30-5:30 PM
- May 10 Curriculum Library, 4:30-5:30 PM

National Board Certification is the highest credential in the teaching profession and is a voluntary process established by the National Board for Professional Teaching Standards (NBPTS). Certification is achieved through rigorous performance-based assessments that can take 1-5 years to complete. The process measures what accomplished teachers/librarians or school counselors should know and are able to do. In addition, holding a valid NBPTS certificate satisfies the ongoing clock hour requirement for 5 years of a teaching certificate, or the requirements of the Washington State Professional Certificate, whichever is applicable.
