WEA to drop Premera in favor of United Health Care and Aetna

Last June, the WEA Board of Directors approved conducting a market evaluation of WEA's sponsored medical plan, Premera, to determine if the plan was meeting the needs of members both in cost and in coverage. After identifying what plan members considered to be the most important elements of a health care plan, WEA put its medical plan out for bid.

WEA's Benefit Services Advisory Board spent seven months reviewing insurance carrier proposals, receiving presentations, and conducting site visits to customer service centers. Three carriers emerged as finalists---Premera, Aetna, and United Health Care. After thorough evaluation, two carriers were approved---United Health Care and Aetna.

As a result, Premera will no longer be the WEA-endorsed plan as of November 1, 2017.

What does this mean for Lake Washington? At this point, we're not exactly sure. Here are some possible scenarios:

- Nothing changes. LWSD continues to offer the same Group Health (now Kaiser) plans, plus Premera Plan 3. Premera would not be endorsed by WEA, so we may have to negotiate rates and coverage locally with Premera instead of statewide by WEA.
- LWSD continues to offer the same Group Health (Kaiser) plans, drops
 Premera, and picks up Aetna and/or United Health Care as additional options.
- LWSD drops Premera and becomes exclusively Group Health (Kaiser).

The LWSD Benefits Advisory Committee, made up of representatives from all employee groups (including LWEA), will make a recommendation once more information is available about the plans and what the impact would be in making any changes to our plan offerings. As of now, we don't have rate or coverage information on Aetna and United Health Care, nor do we know what Premera will do in response to losing 100,000+ enrollees in the WEA market. Specifically, we don't know if we'll even be able to offer Premera next year, much less what the rates and coverage might be.

Even though we have very few details at this time, we thought it was important for you to hear from us as soon as possible about WEA's decision to drop Premera. We'll continue to seek more clarity on the issue and will share with you any developments that arise.
