Make sure your students are always supervised

It's important to understand that proper supervision of students is a professional responsibility required by the state's Code of Professional Conduct. While it's not always possible to watch every single student in your class 100% of the time, teachers and other school employees are expected to exercise good judgment in ensuring that students are never left unsupervised.

Here are some tips to make sure your students are safe, as well as helping to prevent you from being disciplined, sued, or possibly having your certificate revoked:

- Be in visual contact with your class at all times, especially when you step out of the room to meet with an individual student or other staff member.
- If you need to leave the room to run to the office or use the restroom, make sure you've arranged for another staff member to watch your class in your absence. Never leave students unattended in your classroom.
- If you teach subjects such as lab sciences, tech/ industrial arts, physical education or any other class in which student safety is of greater concern than in a regular classroom, the standards of supervision are higher for you.
- If you send students out of the classroom to work on projects, make sure they are clear as to what your expectations are for their behavior. Only send students who have demonstrated to you that they will behave responsibly. Be aware of equipment or other situations that might tempt students to get into trouble or cause them physical harm. Check on your students frequently.
- If the physical environment of your classroom or existence of other factors causes you to feel you're unable to adequately supervise your students, it's important to meet with your building principal to resolve these concerns as soon as possible. Document your concerns in writing to your building administrator and keep a copy for yourself. If you need help getting your concerns resolved, please contact the LWEA office.

Following these guidelines will likely prevent any problems from happening. If, however, you find yourself faced with an accusation that you've failed to properly supervise your class, especially if the injury of a student is involved, contact the LWEA office immediately (425-822-3388). What bargaining can do...

Then: Teachers had no way of finding out what was being kept in their building and district files.

Now: Teachers have a process for viewing their building and district files. Article 16 (pages 22-23 in the <u>LWEA/LWSD contract</u>) describes what can be placed in the files and the process that should be used to view a file.

Keep in mind that an appointment needs to be made in advance in order to review either file.



Still working on your taxes?

If you're planning to do your taxes this week, don't forget that you can deduct most (but not all) of your association dues from your income tax. The dues deduction amount for teachers is a follows:

.76 - 1.0 FTE	\$1,045.56	.5175 FTE	\$913.44
.2650 FTE	\$546.28	.125 FTE	\$373.29

Please remember that your 2016 dues for income tax purposes includes 8 months at the 2015-16 dues rate and 4 months at the 2016-17 dues rate.

If you changed FTE from last year, keep in mind that your dues amount will be different - you will need assistance in determining the correct dues amount.
