What do I do with my clock hours?

We get that question and others related to credits and transcripts quite a bit, especially at this time of year. Since there are often several different answers to these questions depending on how or where the credit/transcripts have been earned, our goal is to try to clear up some of the confusion.

Clock hours and college credit can both be used to advance on the salary schedule and for renewal of your certificate. It takes 10 clock hours to equal 1 college quarter credit, so keep in mind that if you have a class that would allow you to gain either 18 clock hours or 1 quarter credit, the 18 clock hours will move you further on the salary schedule. The deadline for both clock hours and transcripts is September 30 for advancement in 2018-19.

You should be aware that clock hours can't be applied to higher education college programs and may not be portable should you move out of state.

Please note:

- Individuals are responsible for their own documents and submission to Human Resources (HR) for advancement on salary schedule and OSPI for certification.
- The information that needs to be sent to HR to receive credit for advancement on the salary schedule includes actual transcripts or clock hour receipts along with the <u>Credit Approval Form</u>.
- The District's Professional Learning department does not report clock hours that you have earned to HR or OSPI. That is your responsibility.
- LWEA, WEA, and other outside agencies don't provide the District with your transcripts or receipts. These are given to you and it is your responsibility to send the forms to HR along with the <u>Credit Approval Form</u>.
- The District does not report your clock hour or credit information to OSPI. It is
 your responsibility to communicate that information in order to advance on the
 salary schedule as well as keep your certificate current and renewed. This is
 done using the <u>E-Certification system</u> through OSPI.

Important: In order to receive clock hours for your Quality Professional Learning (half page pink sheets used for LEAP time), send the forms to the Professional Learning Department by May 5 for processing. Do not combine these sheets with any other clock hour transcripts or receipts from any other training.

Learn About National Board for Professional Teaching Certification

Have you been considering pathways towards professional certification? Then we invite you to attend this information session on May 10 (from 4:30 - 5 PM) in the Curriculum Library at the Resource Center.

National Board Certification is the highest credential in the teaching profession and is a voluntary process established by the National Board for Professional Teaching Standards (NBPTS). Certification is achieved through rigorous performance-based assessments that can take 1-5 years to complete. The process measures what accomplished teachers/librarians or school counselors should know and are able to do. In addition, holding a valid NBPTS certificate satisfies the ongoing clock hour requirement for 5 years of a teaching certificate, or the requirements of the Washington State Professional Certificate, whichever is applicable.

Thinking about lifting that box?



As the school year comes to a close, many of you may find yourselves faced with moving to a different building or a different classroom within the same building. Please remember that it's extremely important that you not lift or move heavy boxes, furniture or equipment, since doing so can put you at risk for serious injuries.

District-owned items will be moved to your new location over the summer. Make sure you label clearly so that the items make it to their destination without any problems.

You're responsible for moving all of your own personal items. Use extreme caution in doing so. Pack boxes lightly and lift only what you can reasonably handle. Enlist the help of others for heavier objects. For those who have to move personally-owned larger items like sofas, bookcases, and other furniture, consider using a professional moving service.

This is also true for elementary science kits. Teachers should not be moving heavy science kits to and from their classrooms. Ask your custodian to move the kits for you.

The risk of injury is not worth it - when in doubt, don't move it!
